

Welcome to our community newsletter

North Mundham Parish Council Business Plan and Strategic Action Plan.

At its meeting on 2nd May 2017 the Parish Council adopted a five year business plan which covers the period 2017-2022 a summary of this has been circulated with this newsletter. A full copy of the plan is available on the parish council website. From the Business Plan the Parish Council has adopted its strategic actions for the current Council year.

The priorities set for this year are:

- Apply for Accreditation—submit the application for Quality Award.
- ◆ Canal Mead Footpath— provide a permissive path
- Neighbourhood Plan—work towards the production of a neighbourhood plan
- Review Parish Plan—to be reviewed as path of the Neighbourhood Plan Project
- Monitor Development of the School Lane Site - Ensure Developer adheres to Planning Conditions
- Website Review the site to ensure it meets the public needs and the site is
- Village Hall Marketing Project—increase usage of the hall
- Village Hall Refurbishment—replace curtains and poles in the small hall and the main hall.

We are pleased to say that we have been working on all these projects and there are further updates on some of these projects throughout this newsletter.

Canal Mead Permissive Path.

The Parish Council is very pleased to report that the contractor has been instructed to carry out the work to provide this much needed permissive path, although we do not have a start date yet. We will be contacting those directly affected as soon as we have a date. We successfully applied for grants which has covered 50% of this project.

When residents selected this site as a preferred option to provide affordable housing in the parish, the main area of concern was the residents of these lovely houses being able to integrate with the rest of the village and the issue of crossing such a busy road. We hope that this path will address both these issues and we look forward to this project being completed this winter.

We also hope that by improving this area it will reduce the fly tipping that blights the canal currently.

Neighbourhood Plan

At the Annual Meeting of Electors in May the Parish Council provided you with an update on the decision to produce a Neighbourhood Plan. As those of your who attended are aware the Parish Council were reconsidering the decision taken to produce a Neighbourhood Plan.

The following factors have been taken into consideration by the Parish Council when reaching this difficult decision .

- The Neighbourhood Plan (NP) could be in prolonged conflict with the Local Plan. The protracted timetable for the development of a Neighbourhood Plan means that during this period the Local Plan will be reviewed and amended with a possible re-allocation of housing for the parish. In this case the emerging NP would become redundant thus requiring a re-set of the NP development period.
- The long period required for developing the NP, say 3 years, means that it cannot be used as a consultation document during this period.
- A Parish Plan could be produced far more quickly. Whilst there is no mandatory requirement for the Local Planning Authority (LPA) to refer to a Parish Plan the Parish Council feels it could be a more effective consultation on planning applications. It is hoped that with good relations and a strong plan in place then the LPA would use the Parish Plan as a material consideration in the determination of all key applications.
- There is more scope to develop a Parish Plan that responds to the particular needs of the parish. It can be a more agile document that doesn't need to pass the extreme level of external consultation and audit.
- In time the Parish Plan can be amended more readily in order to respond to changing development pressures on the parish and surrounding area.

A working party is now investigating the remit and forming the project plan to work towards the production of a Parish Plan which will driven by firm evidence from the parishioners. The Parish Plan will support the objectives in the adopted business plan.
